#### MINUTES

Chair Chappell called the meeting to order at 1:15 p.m. in person.

The following members in attendance: Ms. Traci Butler, Mr. Earl Caison, Ms. Perry Chappell, Mr. Jeff Clark, Mr. Carlton Fisher, Mr. Steve Griffin, Mr. Robert Rippy, Dr. Yousry Sayed, Mr. Kevin Sills, Dr. Jimmy Tate were present. Dr. Aswani Volety, Chancellor; Vice Chancellors Mr. Eddie Stuart, University Advancement; Mr. Miles Lackey, Business Affairs and Vice Chancellor Dr. Chrisine Reed Davis, Student Affairs, represented the university. Deans attending were: Interim Dean Dr. Carol McNulty, Watson College of Education, Founding Dean Dr. Ronald Vetter, College of Science and Engineering, and Dr. Jack Watson, Dean, College of Health and Human Services. Also attending were other university administrative personnel.

The meeting moved into the Business portion of the meeting. Chair Chappell read the Conflict of Interest Policy to all and asked if anyone had a conflict of interest. No such conflicts from the Board members were noted for the open session.

Chair Chappell asked Ms. Sharon Lindgren to call the Roll and it was determined that a quorum was present.

A motion was made to approve the October 13, 2023 meeting minutes and the minutes were unanimously approved.

Chair Chappell introduced Dr. Winebrake, Provost and Vice Chancellor Academic Affairs who introduced Dr. Colleen Reilly, Faculty Senate President.

Dr. Colleen Reilly presented the Faculty Senate report. She provided updates on the activities of the Faculty Senate since the October 2023 meeting and highlights and priorities of this semester including an Ad Hoc Committee on Faculty Workload that has been appointed; progress on RPT timeline motions; and updated academic policies related to declaration of major, requirements for graduation, and changes to the readmission and three-year forgiveness policies. She then introduced Dr. Daisyane Barreto, Associate Professor, WCE, Department of ITFSE, who spoke on a faculty initiative: Learning & Design Masterminds: Connecting UNCW alumni, students & community.

Provost Winebrake presented the Academic Affairs report. Included were AA highlights, recognitions and awards, and an overview of how new UNCW academic programs are developed, from ideation to implementation.

Dr. Winebrake then introduced Dr. Christine Reed Davis, Vice Chancellor Student Affairs, who provided updates on recent activities and highlights for the Division of Student Affairs. She then introduced Dr. Mark Perez-Lopez, Director of Counseling and Testing Centers, who presented on the University Counseling Center Student and Campus Support Services, including resources and support for student

mental health.

Chair Chappell thanked everyone for their presentations and information.

At 2:27pm, Chair Chappell asked if there was any old, unfinished, or new business to address. Hearing none, a motion was made to adjourn the session.

Upcoming Required BOT Approvals, provided by Dr. James J. Winebrake, Provost and Vice Chancellor for Academic Affairs.

#### Situation:

The Division of Academic Affairs is developing or amending a number of policies, or other official institution documents, to meet new UNC System Office (SO) requirements. Provost Winebrake will provide the UNCW Board of Trustees (BOT) an overview of key items expected to require BOT approval in the coming months.

#### Background:

Faculty Workload: The UNC SO has distributed new guidance related to faculty workload (UNC Policy 400.3.4). Using this guidance, a UNCW Faculty Senate Ad Hoc Committee has drafted new institutional guidelines on faculty workload. These guidelines were introduced to Faculty Senate in March and will return to them for endorsement in April. From those guidelines, institutional policy will be developed that will then come to BOT for approval.

Reappointment, Tenure, and Promotion: A Faculty Senate ad hoc committee has made recommendations that affect RTP policy at UNCW. In addition, regulations from the UNC SO on Teaching Effectiveness and Post-Tenure Review (600.2.5.2[R], 400.3.1.1[R], and 400.3.3.1[R]) were adopted by BOG in March. Any amended UNCW RTP policies will come to BOT for approval, as appropriate.

Academic Program Planning: In March, UNC SO distributed proposed new regulations for academic program review (UNC Policy 400.1.1) that require each campus to modify its academic program review processes and procedures. The UNC SO proposal will be voted upon in April by the BOG. Any amended UNCW plans will be brought to BOT for approval, as required by the UNC SO.

Presentation on increased usage of the Disability Resource Center (DRC) and services offered for student support, both in and out of the classroom, by DRC Director, Katie Krieger, and Associate Vice Chancellor for Student Affairs, Dr. Brian Victor.

#### Situation:

Review of the increased usage of the Disability Resource Center (DRC) since 2017, including efforts to enhance services to meet the growing demand from the student population. Debrief on current efforts to disseminate information on resources and services to faculty, staff, students, and administrators. Recommendations are made for next steps to ensure services continually meet the requirements under the Americans with Disabilities Act (ADA) and the expectations of both administration and students, and that necessary resources are allocated for the expanding need.

#### Background:

In 2017, the Disability Resource Center (DRC) had 743 registered students. As of December 2023, the number of registered students increased to 1,855. With an almost 150% increase in registered users over the past 6 years, the DRC is working to expand staffing, resources, and services to meet the growing student demand.




### Overall Trends at UNCW

### **Enrollment Headcount by Level**




### Overall Trends at UNCW






### Trends by College (Degrees Awarded)




### Trends by Degrees Awarded: CSB




### Trends by Degrees Awarded: CHHS




### Trends by Degrees Awarded: CHSSA

### New Program Decision Making: Factors

- Existing programs in UNC System
- Relation of the program to the distinctiveness and mission of the campus
- Student demand for the program in the region or state
- Regional, state, and national data on **employment opportunities** for program graduates at the degree level proposed (including **market assessments**)
- **Faculty available** for offering a high-quality program
- **Campus resources** available to offer a high-quality program (library, space, labs, equipment, external funding, etc.)
- Five years of projected revenues and expenses associated with the program
- Impact of program on **access and affordability**, including comparison of expected earnings of graduates with projected costs of earning the degree (or student debt)
- Expected academic quality of the degree

### Policy Modifications in Academic Affairs

The Division of Academic Affairs is developing or amending policies to meet System Office (SO) requirements:

- Faculty Workload Policy
- Reappointment, Tenure, and Promotion (RTP)
- Academic Program Planning
- Post-tenure Review
- Foundations of American Democracy
- Teaching Effectiveness Assessment

# Key items will require Board of Trustee action in the coming months.



### Faculty Workload Policy

- New guidance from UNC System Office directs campuses to revise faculty workload policy to be consistent with UNC Policy 400.3.4.
- On April 16, Faculty Senate endorsed an ad hoc committee report on new institutional guidelines that creates a *differentiated workload model*.
- Office of the Provost and Faculty Senate now working on UNCW policy based on guidelines and SO requirements.

**Role of the Board:** New UNCW policy will come to Board of Trustees for approval (Summer 2024).



### Academic Program Planning

- New regulations from UNC System Office require campuses to revise policies related to academic program review at the undergraduate and graduate level.
- Faculty Senate and Office of the Provost working to assess current UNCW policies vis-à-vis new regulations.
- Goal: Policy changes endorsed Faculty Senate approval in Fall 2024.

**Role of the Board: A**mended UNCW polices will come to the Board of Trustees for approval (Winter 2024/2025).



# Reappointment, Tenure, and Promotion (RTP) / Post-Tenure Review (PTR)

- Regulations on Teaching Effectiveness and Post-Tenure Review (600.2.5.2[R], 400.3.1.1[R], and 400.3.3.1[R]) were adopted by the UNC Board of Governors in March.
- On April 16, Faculty Senate approved recommendations provided by an ad hoc committee on UNCW RTP.
- Office of the Provost now working with key partners to update *Faculty Handbook* and related systems with proposed changes.

**Role of the Board:** If changes are made to UNCW RTP policy, the amended policy will come to the Board of Trustees for approval before changes take effect.

  - Campus Testing Center makeup testing for all students




### What We Do

- Supplement with reasonable accommodations to ensure access.




### Total Registered Students

### **Disability** Types (As of March 31, 2024)




### Accommodations
