



UNCW Continues to Excel at Preparing UNC System Graduates

UNCW came out very well on UNC System Return on Investment (ROI) study.

- UNCW has the highest ROI to the state of North Carolina's investment, with an average of \$31.33 being returned for UNCW grads for every dollar invested, compared to \$23.07 for all UNC System Institutions.
- UNCW is the 3rd Lowest in the UNC System in median incremental cost per graduate to the state at \$26,274, behind only FSU and UNC Pembroke. The UNC System average is \$35,088.
- 85% of UNCW's undergraduate programs and 74% of graduate programs included in the study had positive ROI for students.
- 100% of UNCW's undergraduate and graduate programs in health professions and education (critical workforce areas) had a positive student ROI.



Students and Families – Return on Investment

UNCW has the 5th highest median incremental lifetime earnings to the student in the UNC System at \$837,216.

- This places us behind, in order: NC State, UNC CH, App State, and UNC Charlotte.
- The UNC System average: \$809,616.

UNCW's median ROI for all programs are as follows:

- UG programs: \$326,484 (UNC System median: \$371,836)
- Grad programs: \$779,615 (UNC System median: \$723,649)



ROI Assessment Continues

- Approximately 25% of the undergraduate and 34% of grad programs had sample sizes too small to be included in the public dashboards, indicating that the data may not be statistically valid. Many of the negative ROI programs are in these small sample size groups.
- We're exploring ROI data to see what corrections need to be made.
- Among the UNCW programs with seemingly negative ROIs:
 - The range goes from approximately \$8,000 to \$425,000.
 - When considering the lifetime earnings over time (est. 43 years), this equates to approximately \$190 to \$9,900 annually for an individual.
- We are working with these programs to outline areas for possible improvement.
 - A report is due to the System Office in mid-March for presentation to the UNC Board of Governors in April.

Human Resources

- Expansion of EHRA Classifications (Senate Bill 195)
 - Recently implemented legislation expands the number of positions that are exempt from the NC Human Resources Act to include SHRA positions that are exempt from the federal Fair Labor Standards Act (FLSA).
- SHRA Career Banding Salary Ranges Project
 - New market-based salary ranges were developed in 2023 and approved by the State HR Commission. Currently awaiting the Governor's signature and UNC System implementation guidelines.
- Nursing Faculty Salary Adjustment Fund
 - The 2023 Appropriations Act provided \$1.9M in recurring stateappropriated funding to support increased salaries for nursing faculty.
- UNC System Employee Engagement Survey
 - Fourth survey to be distributed March 2024.
