Special Called Meeting Minutes March 26, 2025

The Board of Trustees of The University of North Carolina at Wilmington held a special called meeting on March 26, 2025, in Alderman Hall Room 215, with some members participating via electronic connection. Chair H. Carlton Fisher called the meeting to order, welcomed participating members, and read the conflict-of-interest statement in compliance with the State Government Ethics Act. No conflicts or appearances of conflict were identified.

ROLL CALL

Assistant Secretary Jennifer Groves called the roll and established that a quorum was present. Members of the Board participating in person were Earl F. "Hugh" Caison II, H.
